BY-LAWS

DIAMOND-STRINGTOWN NEIGHBORHOOD ASSOCIATION

Boundaries:

Diamond-Stringtown Neighborhood Association is bounded on the **East** by the west side of Kentucky Ave., on the **South** by the north side of Maxwell Ave., Stringtown Rd to Enlow Ave., and on the north side of Enlow Ave. on the **West & North** by the east side of Governor Ave. to Diamond Expy., Diamond Expy to Pigeon Creek, the east & south side of Pigeon Creek to Kentucky Avenue

In 2005 Rewritten, but NOT Changed.

Term of Office:

Officers shall be elected for 2-year terms. Nominations will be taken in September of the election year with names of nominees printed in the minutes of the September meeting. Election will be held at the October meeting. Any member is eligible to hold an office. An officer may succeed him/herself. Officers term shall end on October 31st, of each odd year, (2003, 2005 and etc.)

BY-LAWS

DIAMOND-STRINGTOWN NEIGHBORHOOD ASSOCIATION

Name: The name of this organization shall be the Diamond-Stringtown Neighborhood Association hereinafter referred to as DSNA. No part of these By-Laws shall be construed as conflicting with city, state, or federal laws.

Purpose: To promote and maintain a safe, clean, attractive, friendly neighborhood where residents are respectful and supportive of each other.

Boundaries: Diamond-Stringtown Neighborhood Association is bounded on the EAST Side by the west side of Kentucky Ave to Maxwell Ave; on the SOUTH side by the north side of Maxwell Ave to Stringtown Rd, down Stringtown Rd to Enlow Ave, then by the north side of Enlow Ave to Governor Ave; on the WEST and NORTH sides by the east side of Governor Ave to the north side of Diamond Expressway, from there to the east and south sides of Pigeon Creek back to Kentucky Ave, the place of beginning.

Membership: Those eligible for membership shall include the following: homeowners, property owners, businesses, tenants, and not for profit organizations located within the defined boundaries. Friends of DSNA living in Vanderburgh County.

Voting rights are restricted to dues paying members.

Membership Dues: Dues for the coming year shall be determined by a majority vote of the members present at the September meeting. (Current dues are: Individual/household \$5.00 yearly, Property owners or friends of DSNA \$5.00 yearly, Businesses or organizations \$5.00 yearly. Churches located in DSNA are members without dues.)

Meetings: Meetings shall be held on the first Tuesday of each month. In the event that the first Tuesday is a major holiday an alternative meeting date may be agreed upon by the members.

Special Meeting: Any member may request special meetings, social functions, etc.

Meeting Notice: Meetings or other events will be announced at the monthly meetings.

Quorum: A quorum shall consist of two (2) officers and ten (10) members present at a regular meeting of the DSNA.

Officers: Officers shall be a president, vice president, secretary, and treasurer. Their duties shall be those usually performed by such officers. The Officers and 5 DSNA members approved by the membership shall constitute the Executive Committee.

Term of Office: Officers shall be elected for one (1) year terms. Any member is eligible to hold an office and any officer may succeed him/her self one time. A slate of officers will be presented by the Executive Committee in October with additional candidates nominated from the floor at that time. Election will be held at the November meeting. Newly elected officer will begin their term the day after the December meeting.

DSNA and/or Committee Member Representative to other Organizations or Committees:

DSNA Representatives and/or Committee Members to other Organizations or Committees should be members of DSNA and should be elected by DSNA membership. DSNA President may appoint a Representatives or Committee member temporarily if needed.

Block Captains: Block Captains are appointed by the Executive Committee upon mutual agreement. A Block Captain who is unable to continue to serve is expected to find a responsible replacement for his/her block

Minutes: Minutes of each meeting will be communicated to the membership at a following monthly meeting.

Committee: In addition to a Social Committee, other committees may be formed as the organization sees need or demonstrated interest.

Amendments: These By-Laws may be amended in whole or in part by the majority vote of members present at any regular meeting
