MISSION STATEMENT

THE MISSION OF GLENWOOD NEIGHBORHOOD ASSOCIATION IS TO WORK IN COOPERATION WITH RESIDENTS, BUSINESSES IN THE AREA, THE EVANSVILLE POLICE DEPARTMENT (EPD), CIVIC ORGANIZATIONS AND WITH CITY OFFICIALS TO CREATE IMPROVEMENTS WITHIN THE COMMUNITY WHICH LEAD TO A SAFE AND HEALTHY QUALITY OF LIFE FOR ALL WHO RESIDE WITHIN GLENWOOD ASSOCIATION BOUNDARIES.

ARTICLE I

NAME-BOUNDARIES

- A. THIS COMMUNITY ORGANIZATION SHALL BE KNOWN AS THE GLENWOOD NEIGHBORHOOD ASSOCIATION (GNA).
- B. THIS ASSOCIATION IS BOUNDED BY HOWARD STREET ON THE WEST, KENTUCKY ON THE EAST, RIVERSIDE ON THE NORTH TO SOUTHLANE DRIVE ON THE SOUTH.

ARTICLE II

PURPOSE

A NON-PROFIT ORGANIZATION TO PROMOTE COOPERATION AND UNITY THROUGH GROUP ACTIVITY FOR IMPROVEMENT OF THE COMMUNITY.

ARTICLE III

MEMBERSHIP

MEMBERSHIP IS OPEN TO ALL WHO RESIDE OR WHO OWN BUSINESSES WITHIN THE BOUNDARIES
ALL MEMBERS ARE ELIGIBLE TO VOTE.

ARTICLE IV

MEETINGS

- A. MEETINGS SHALL BE HELD MONTHLY.
- B. TIME AND PLACE FOR MEETINGS SHALL BE PUBLISHED IN THE MONTHLY NEWSLETTER.

ARTICLE V

DUES

THERE WILL BE NO CHARGE TO JOIN GLENWOOD NEIGHBORHOOD ASSOCIATION.
HOWEVER, A YEARLY DONATION WILL BE ACCEPTED.

ARTICLE VI OFFICERS AND DUTIES

THE EXECUTIVE COMMITTEE WILL BE ELECTED BY MEMBERS AND MAY CONSIST OF PRESIDENT, VICE -PRESIDENT, SECRETARY, ASSISTANT SECRETARY AND THE FINANCIAL SECRETARY (TREASURER). TERM OF EACH OFFICE SHALL BE ONE YEAR* (SEE ARTICLE VIII)

- A. PRESIDENT SHALL OVERSEE OPERATIONS OF THE GLENWOOD NEIGHBORHOOD ASSOCIATION AND PRESIDE OVER ALL MEETINGS.
- B. VICE-PRESIDENT SHALL ASSIST PRESIDENT AND PERFORM DUTIES OF THAT OFFICE IN THE ABSENCE OF THE PRESIDENT .
- C. SECRETARY SHALL RECORD ALL PROCEEDINGS, MINUTES AND OTHER ACTIVITIES OF THE GLENWOOD NEIGHBORHOOD ASSOCIATION.
- D. FINANCIAL SECRETARY SHALL RECEIVE AND RECORD ALL EXPENDITURES AND MONIES PAID TO THE GNA.
- E. ALL CHECKS SHALL BE SIGNED BY TWO OFFICERS PREFERABLY, THE PRESIDENT AND THE FINANCIAL SECRETARY.

ARTICLE VII COMMITTEES

- 1. EXECUTIVE COMMITTEE
- 2. BY-LAWS COMMITTEE SHALL CONSIST OF FIVE(5) MEMBERS OF THE GNA
- 3. POLITICAL ACTION COMMITTEE (PAC)
- 4. EDUCATION COMMITTEE
- 5. FUNDRAISING COMMITTEE

ARTICLE VIII ELECTIONS

TERM OF OFFICE FOR ALL ELECTED OFFICERS SHALL BE TWO(2) YEARS (EFFECTIVE JANUARY 2010) AND SHALL RUN FROM **JANUARY 1 TO DECEMBER 31**. NOMINATIONS AND ELECTIONS SHALL BE HELD IN NOVEMBER, TWO MONTHS PRECEDING NEW TERMS.

ARTICLE IX PROPOSALS AND AMMENDMENTS

- A. PROPOSALS MAY BE SUBMITTED IN WRITING AT ANY REGULAR MEETING.
- B. PROPOSED AMENDMENTS SHALL BE EFFECTIVE UPON TWO-THIRDS (2/3) MAJORITY VOTE.
