The Mission: Creating solutions to prevent and to end chronic homelessness in our community The Vision: We believe that everyone has value and needs a safe, decent affordable place to call home

- 488 homeless count with 92 of them being street population
- Services for Walk-in Clients 4,056
- Total Served 1,395
- Total Mileage 22,385 (food runs, move ins, outreach, lease signing, appointments)

Our Programs: - the numbers represent those that exited to permanent housing

- Rapid Rehousing 194
- Housing First 29
- Vision 1505 6
- Beacon PSH 34
- Re-Entry 50
- Outreach
- Prevention

Zac reported that 48 hours of living homeless is exhausting. They didn't even get recognized by their own family members.
