February 2024

Mayor Stephanie Terry will reconvene the city's Traveling City Hall tradition this month.

The first **Traveling City Hall** of the Terry administration will be held in partnership with United Neighborhoods of Evansville on Thursday, February 22, at 5:30 p.m. in the C.K. Newsome Community Center. It will precede the regular United Neighborhoods of Evansville meeting, scheduled for 6:30 p.m., where Mayor Terry also will speak.

"One of the best parts of running for mayor was having the opportunity to hear directly from the people of Evansville – to hear their concerns, answer their questions, and to just listen to what they have to say about our city," Mayor Terry said. "The Traveling City Hall is an opportunity for me and the department heads from across the city to continue not only doing that, but to take their concerns back to the office the next day and do what we can to address them in real time."

Mayor Terry's administration will host quarterly **Traveling City Hall** meetings throughout 2024, with each being held in a different part of the city, in conjunction with different community partners.

"United Neighborhoods of Evansville is excited to partner with Mayor Terry's administration for the first of her Traveling City Hall programs," said Joe Ballard, United Neighborhoods of Evansville operations manager. "This kind of direct dialogue between citizens and city officials is critical to a strong, thriving Evansville, and we're proud to be part of making that happen."

Future **Traveling City Hall** meetings will be held in May, August, and November 2024. The dates, locations, and community partners associated with those events will be announced at the February 22 event.

Lead Abatement Program

Do you know that EPA wants to sample your yard for lead and arsenic to protect children's health.

Due to historic industrial operations in your area, many residential properties within the Jacobsville Neighborhood Soil Superfund Site (see map) have been contaminated with unsafe levels of lead and/or arsenic. Children are especially susceptible to health effects from lead exposure, including ability to learn, pay attention, and do well in school.

The mission of the U.S. Environmental Protection Agency (EPA) is to protect human health and the environment. Therefore, if you live within the Superfund Site (see map), the EPA wants your permission to sample your yard **at no cost to you**. About 7,000 properties have been sampled to date!

If your sample results show your soils have high levels of lead or arsenic, the EPA will excavate those soils and replace with clean soil – that's right, **at no cost to you**. To date, over 4,000 residential properties have been cleaned up and restored. Before EPA can begin sampling or excavation, we need your written permission (also known as an access agreement). To request an access agreement, contact one of the EPA staff below.

Evansville Newslab

The United Neighborhoods of Evansville would like to introduce you to the **Evansville Newslab** project and ask for your help.

Why Newslab? Evansville, like other communities, suffers from declining news resources. This means local government business is often conducted "in the dark." One way to shine a light on governance is by local residents capturing information and making it accessible to various communities through distribution methods that meet their news-seeking behaviors.

What is Newslab? A research project conducted by the University of Evansville Changelab and its students, in partnership with *Our Times* newspaper and Listening Post Collective, a nonprofit organization supporting community-driven journalism.

What is it designed to do? Foster civic engagement in the community and promote *non-partisan* civic journalism.

How will this be carried out? We aim to gain an understanding of how residents engage with local news and their level of engagement. Additionally, the project will identify specific information needs and preferences, as well as gaps and opportunities to improve local news coverage.

What outcomes do we expect? We will use the results to understand the news and information needs and provide resources so that the local news infrastructure can meet these needs for the community. Once completed, we will share the results with the community.

How you can help our effort: Take the survey to help profile our local community news habits and needs. Just scan the QR code to take the survey. Let other people know about this effort and ask them to take the survey.
