The Healthy Indiana Plan

State accepting applications for new health insurance program

Local residents are now able to apply for a new health insurance program created by the legislature in 2007.

The Healthy Indiana Plan will provide health care to over 130,000 working adults and families. The plan is available for those who earn less than double the federal poverty rate—\$19,600 for a single person or \$40,000 for a family of four.

The five-page application is available online at www.Hip.in.gov, at local Family and Social Services Administration offices or by calling 877-438-4479. The state is currently processing applications on a first-come basis.

Participants in the plan will pay up to 5 percent of their income based on a sliding scale that begins at 32 percent for individuals who earn \$9,800 or less. They will have access to preventive care, such as mammograms and prostate exams, and receive a \$1,100 health savings account to cover doctor visits and other expenses.

The plan also includes tax credits to small businesses that offer wellness programs and to employers who offer health benefit plans for the first time.



State Senator Bob Deig ~ Session Highlights

Representing Senate District #49 including Gibson, Posey, and Vanderburgh counties.

The fast-paced atmosphere surrounding the Indiana General Assembly this week marked the arrival of crucial mid-session deadlines. Of the 368 bills and 22 joint resolutions introduced in the Senate in early January, 154 bills and 5 joint resolutions moved out of committee to the full Senate for consideration by the full body. Bills which gain approval in the first house will advance to the opposite chamber for its review throughout February. The following brief summary highlights some of the latest legislative activities.

Property tax reform

Property tax proposals continue to dominate activities in both chambers. The House recently approved **House Bill 1001**. Highlights of the comprehensive property tax reform measure include a cap on homeowner's property tax bills at one percent of a home's assessed value beginning in 2009, a two percent cap for rental properties and a three percent cap for businesses. The legislation calls for a state sales tax increase of one percent, creates additional spending limits for local governments and would eliminate township assessors. The Senate will spend the next few weeks considering HB 1001 where changes are expected. The bill will then go to a House-Senate conference committee where members from both chambers will negotiate compromises on different versions of the proposal.

Bills advanced by the Senate

Several bills which have passed the Senate and now proceed to the House for its consideration include:

Senate Bill 56 would require that the U.S. and state flags on the State Capitol be flown at half-staff for 24 consecutive hours not more than 30 days after the date of a service related death of a Hoosier who is a member of the armed forces or the Indiana National Guard.

Senate Bill 176 would create a 12 member courthouse preservation advisory commission to investigate the need for preservation, restoration and maintenance of historic courthouses.

Senate Bill 26 would make it a Class B infraction if a landlord fails to properly install a smoke detector at the time a tenant moves in to a unit or fails to repair an inoperative hard-wired smoke detector within seven days of receiving notice of the need for repair. The bill also provides that neither the landlord or the tenant may waive the requirement that a smoke detector be installed.

Senate Bill 91 would require the Department of Child Services to promote sibling visitation for every child who receives foster care.

Senate Bill 208 would allow a county to authorize all county taxpayers to pay property taxes by automatic deduction from a checking account on a date chosen by taxpayer. In addition, the bill provides that a county council may also authorize the payment of property taxes by a monthly installment plan.

Senate Bill 262 would allow a student who has resided in a school corporation for at least two consecutive years prior to moving to an adjacent school corporation to continue to attend school in the former school district without transfer tuition being charged.

Senate Bill 283 would authorize the Bureau of Motor Vehicles to adopt rules to allow for the renewal of certain driver's license by mail or by electronic service.

To stay informed about legislation moving through the Indiana General Assembly, log on to www.in.gov/legislative/. From this site, you can research bills, review committee calendars and legislative floor calendars, view full bill texts and watch Senate and House sessions as well as some committee hearing which are broadcast live.

In addition, citizens can stay informed on bills scheduled for action in the House and Senate chambers through a free on line program available at www.BillWatch.in.gov/. This program allows you to track up to ten bills. Email notifications are sent once per day if action is taken on tracked bills and /or resolutions. If no action is taken, e-mail notifications will not be sent.

10 Tips to Green Your Home While Maintaining It

- 1. Insulate the attic, basement and crawl space. About 20 percent of energy cost comes from heat lost in those areas.
- 2. Restore porches and awnings. Porches, awnings, and shutters were intended for shade and insulation. To save energy, draw shades on winter nights and summer days.
- 3. In summer open the windows and use fans and dehumidifiers, which consume less energy than air-condition. Many old houses were designed with good cross ventilation; take advantage of your homes layout.
- 4. Keep door airtight by weather stripping, caulking, and painting them regularly. Recent studies suggest that installing a storm door is not necessarily cost effective.
- 5. Install fireplace draft stoppers, attic door covers, and dryer vent seals that open only when your dryer is in use. An open damper in a fireplace can increase energy costs by 30 percent, and attic doors and dryer vent ducts are notorious energy sieves.
- 6. Reuse old material such as brick, stone, glass and slate when making home improvements. If you're rebuilding a staircase, for example use wood from the summer kitchen or shed that couldn't be saved.
- 7. Keep original windows intact. Studies show that older windows can perform as well as vinyl replacements. Weather-strip them so they can seal tightly caulking, exterior trim, and repair cracked glazing or putty around glass panels. You'll reduce landfill waste and the demand for vinyl, a non-biodegradable material that gives toxic byproducts when it's made.
- 8. Use light paint colors for your houses exterior. Lighter colors reflect heat better than darker ones.
- 9. Plant trees. Evergreen tress on the North and West sides of your house can block winter winds, and leafy trees on the South and West provide shade from the summer sun. Using old photos of your house, try to match the historic landscaping.
- 10. Have energy audit done by your local utility company, or visit Home Energy Saver (http://hes.lbl.gov). Audits can help pinpoint problem areas and measure energy savings after you improve your home's efficiency.
