#### Special Storm Debris Program

Mayor Jonathan Weinzapfel, the Evansville Water and Sewer Utility and Allied Waste announce plans to help residents dispose of large debris that fell from trees during last week's ice storm. Starting Monday, February 16<sup>th</sup>, Allied Waste will conduct a special storm debris curbside collection program.

"Several city departments have been busy removing trees that have fallen on city streets and sidewalks," said Mayor Jonathan Weinzapfel. "We also realize that people have a lot of larger tree limbs on their own property and there needs to be a way to help them dispose of that debris."

Allied will follow the grid pattern normally used for Heavy Trash Pick Up to collect storm debris. Pick up will start on the east side and work its way west (please see insert map). Allied will collect storm debris from two grids each day, starting with grids 1 and 2 on Monday, February 16<sup>th</sup>; 3 and 4 on Tuesday, February 17<sup>th</sup>, etc. Debris pick up will not occur on Saturdays or Sundays.

Allied will pick up larger pieces of debris that are no longer than four feet long and six inches in diameter. Storm debris must be placed curbside and does not need to be in any specific container, but it should be stacked to minimize safety hazards. The storm debris should be separate from other waste.

## WARNING: BEWARE OF UNLICENSED UNSCRUPULOUS TREE TRIMMERS—THEY ARE IN THE CITY AND THE COUNTY!

You are liable for any injury or property damage caused by unlicensed tree trimmers. Please note the following:

"It is illegal to trim trees within the City of Evansville without a tree trimming license. For this reason, it is best to ask to see a license before you hire anyone. Dishonest crews may damage your property. Many also do not carry insurance, so you will be liable for damage to your home or your neighbor's home or property. If one of these workers injures themselves on the job, you will be responsible for their bills. To find a list of licensed tree trimmers, go to:

## **ZONING AND REZONING, Part VIII**

We've looked at many aspects of the Area Plan Commission and its staff. This group also serves as the staff for the Board of Zoning Appeals who rule on petitions for variance from the zoning ordinance requirements and Special Uses. Today, we are going to look more in-depth at the BZA.

Basically, the BZA hear and determine appeals concerning any order, requirement, decision, or determination made under the zoning ordinance or enforcement of an ordinance that requires obtaining an improvement location permit or occupancy permit except for decisions by the Evansville and Vanderburgh County APC. In other words, the BZA approve or deny variances from specific zoning requirements, Special Uses and appeals. The BZA has all the powers of the official, officer, board, or body from which the appeal was taken.

Looking at the board's activity over the past few months, most of the appeals they hear deal with set- back rules (how far from the street a building can set), lot coverage, type of parking surface and required parking, height of buildings and, the number and amount of signage as well as Special Uses.

Special Uses include approximately 36 different categories of land use and activities such as schools, churches, hospitals, parks, communication or other towers, massage parlors, some home occupations and many, many more uses. The APC web site has an excellent chart indicating all the Special Uses.

The procedure for requesting an appeal hearing is much the same as for a zoning hearing including notification of abutting neighbors and registered neighborhood associations. Following the public hearing on the requested variance, the BZA must either grant or deny the petition and no variance may be granted except on a finding of all the following factors:

- The approval will not be injurious to the public health, safety, morals, and general welfare of the community.
- The use and value of the area adjacent to the property included in the variance will not be affected in a substantially adverse manner.
- The strict application of the terms of the zoning ordinance will result in practical difficulties in the use of the property.
- The variance is not a variance of the use of the property.
- The petitioner's property is not located in a Planned Unit Development.
- The need for the variance is not created by the applicant.

The Board may incorporate into the granting of a variance whatever conditions or limitations are necessary to protect adjacent properties and the surrounding neighborhood.

This series of articles are not intended to be a definitive study of the code but rather create an awareness on the part of the reader that these subjects are covered in great detail in the zoning code and to seek advice from the APC or other professionals if involved in any of these or other areas of zoning.

Next month we'll cover a few miscellaneous items, look at the legal authority for our zoning laws and start a discussion on the Evansville/Vanderburgh County Comprehensive Plan. 
# "Neighborhood Sparkplugs of the year"

## Keep Evansville Beautiful's EVIE program wins National Award



Keep Evansville Beautiful Executive Director Ann Ennis, Mary Scheller- KEB Program Coordinator-Beautification/Education, Steve & Susan Harp - Oak Hill Neighborhood, and EVIE (the Harp's dog and KEB mascot) attended the 2008 Keep America Beautiful National Conference in Washington, D.C. this past December. The Retrieving With EVIE Litter Program won the prestigious award of first place in the nation for Litter Prevention programs. KEB, Fifth/Third Bank,

the Harps, Jon Siau (illustrator of the EVIE book) and EVIE were all credited with the success of this program. KEB and Vectren also won a second place award at the conference for their collaboration on the Welcome to Evansville sign/project located on Hwy. 41.

Over 300 people and representatives from 40 different states attended the national conference, but EVIE was truly the "hit" of the show. Ann and Susan presented a short overview of the program and watched in awe as Mary, Steve and EVIE entered the room on cue during the "Steal This" session. Keep America Beautiful wanted to keep it a secret that EVIE was a real dog until she walked into the room during the presentation. The crowd went wild! EVIE took the entire **Omni Shoreham Hotel by storm**. KEB heard several times from long-time KAB affiliates that the presentation of Retrieving with EVIE was the best session of the conference and one of the best, most memorable sessions of all KAB national conferences. EVIE showed off her talents at retrieving litter many times during the convention at KEB's booth in the Exhibitors' room. The Evansville group shared information about the program that entices children to civic pride through the hardback book, billboards, litter bags, bookmarks, and school visits (all made possible by Fifth Third sponsorship in 2007 and 2008.) There was a constant line at the EVIE table - she overshadowed all other exhibitors. She was so well behaved that EVIE was invited to attend the Award Luncheon where she received the most applause as she walked across the stage when the litter award winner was announced. She also received a huge piece of prime rib compliments of the director from Keep Smyrna Beautiful.

The idea of using a dog as a mascot to promote anti-litter in Evansville originated in 2004 after Steve and Susan attended the Regional Neighborhood Network Conference in Columbus, Ohio. They learned about the success of Ohio's anti-litter program and mascot, *Lucky the Ladybug* and they began thinking about what Susan could do to educate children in Vanderburgh County. The ideas grew and continue to grow with the help of KEB and sponsors. Mary, Steve and EVIE visited with over 2700 children in public, private and parochial schools in 2008. In addition, the

group has shared the anti-litter message with 1000's of other children and adults by attending community events. They also, worked with Alcoa and WNIN to produce a DVD about EVIE and her anti-litter message. The Harps and Keep Evansville Beautiful believe we must teach the future generations why they should not litter and encourage them to help keep our community clean. Consumers can freeze third-party access to their credit reports until a consumer wants to "thaw" or release them. Since no legitimate business will issue or increase credit without reviewing an applicant's credit report, the freeze stops criminals from falsely obtaining credit in your name. This makes it one of the most effective actions to take to protect yourself from financial fraud. By law, placing a security freeze won't hurt your credit rating and the service is FREE.
