Hello Neighborhoods!

Bank on Evansville

On February 11th 2009, Evansville launched a unique and significant program called **Bank on Evansville**. The program is based on a major initiative developed by the City of San Francisco. Evansville is the only city in Indiana so far that has the program developed and launched. Indianapolis is in the process of developing the program with the help of Evansville's experience.

In November at the UNOE Board retreat we decided to endorse the program and encourage our neighborhoods to learn about the program and support the local efforts. Goosetown Neighborhood Association has had an initial program and Glenwood Neighborhood Association is scheduled for next month. We are just beginning and hope that each neighborhood association will learn about the program and sponsor workshops for your neighbors. This can be at your meetings initially and expand as you see fit. Paul Farmer has been the UNOE representative to this community-wide effort and is available to speak to all UNOE groups and help you plan any next steps.

A financial curriculum has been developed as part of Bank on Evansville and Paul has been trained to conduct the classes and is available for you. Just call the UNOE office to schedule these services.

Over the year there have been many "runs", "bicycle rides", and "walks" in many of our neighborhoods. These are events that are great and support excellent causes but play havoc with neighborhoods because of traffic problems. There is difficulty getting to church when they are on Sundays and in general confusion for the citizens. We are requesting that organizations please contact the neighborhoods with dates and information, so that they can look forward to participating and at least planning their family activities around the outside event. A call to the UNOE office with this information would allow UNOE to share the information with the neighborhoods involved and in return UNOE will give publicity to the organization planning the event.

A great example is the fall **Komen Race for the Cure** that will be downtown for the first time. The neighborhoods have been notified and some are planning little events along the race sites and for those who are visitors and spectators.

This is one way that United Neighborhoods of Evansville can assist agencies and organizations with these types of "special" events and the neighborhoods.

Fred Padget on Land Use Planning, Part I

Last month we finished our series on Zoning and Rezoning but they can still be viewed at the Westside Improvement web site http://westsideimprovement.org/zoning_101.htm or in the United Neighborhoods of Evansville newsletter at http://unoevansville.org/Newsletter.htm.

This new series is going to expand into the area of land use planning. Land use planning and the ultimate use of our land is a wide, varied, interesting and important subject with no lack of opinion. I'm certainly not an expert in land use planning but if I can encourage you to think about it enough to be concerned and, better yet, become involved with land use decisions than I'll feel my time in doing this series will be worthwhile.

I've been involved in land use issues in Evansville and Vanderburgh County as it involves the WIA for several years. A comment I hear very often is "why do we allow that specific land use to happen, why don't we have a plan"? Well, we do and it's a very good one. Its 251 pages long with many additional pages of tables and exhibits. Evansville/Vanderburgh called the Comprehensive Plan and covers most every area of planning. It can be www.evansvilleapc.com/compplan.htm, at the UNOE office, or is available at most libraries. We'll discuss it at length in our forthcoming articles.

Indiana Code does not require that a county or city have a zoning code but they may chose to do so as contained in IC 36-7-4-202. And, if a jurisdiction has decided to have a zoning code, which we have, they must have a Comprehensive Plan as contained in IC 36-7-4-501 and adopted by the appropriate legislative body. In our case, the Comprehensive Plan has been adopted by resolution by Evansville, Vanderburgh County and the Town of Darmstadt. Sounds good so far but then IC 36-7-4-603 says "the plan commission and the legislative body shall pay reasonable regard to: (1) the comprehensive plan". With an emphasis on "pay reasonable regard to" the result is that neither the APC nor the legislative bodies are required to follow the Comprehensive Plan. It boggles my mind. But, it is an important document and provides guidance for good land use planning if, as a community, we have the will and desire to use it.

We'll leave the subject for today and let you ponder about it. In the next few articles, we'll look in-depth at the Comprehensive Plan with an eye to strengthening the term" pay reasonable regard to" and later we'll get into other philosophies of land use planning, and what other communities are doing about it.


2008 "Neighborhood Sparkplugs of the year"

Postage Increase On May 11th

Just a reminder that the cost of mailing a letter will increase by 2 cents on Monday, May 11th. The new 44 cent stamp will be available on that date. For First Class mail there will be no increase in the current additional 17 cents per ounce.

Post Office customers can continue to mail letters for today's price of 42 – cents by purchasing the "Forever Stamps" before May 11th. The "Forever Stamp" is always the First Class single-piece 1 ounce letter price effective on the day it is used.

The first class price change represents an additional \$3.00 over the course of the year for the average household. **All new prices are available at usps.com/prices.**
