#### Land Use Planning, Part IX By Fred Padget

Last month we looked at how interdependent the Comprehensive Plan and good economic development are to each other. The Comp Plan is also supported by many other community attributes such as the education and cultural environment, environmental quality, parks and recreation, public safety and health, transportation and other community characteristics. We'll look at some of those today.

Evansville and Vanderburgh County is fortunate to have many high quality and diverse educational opportunities and facilities for its' residents. The Comp Plan recognized the trend of shifting populations and growth within the city and county and we've seen recent reaction to that by the Evansville-Vanderburgh School Corporation with announcement of changes within the system as well as new schools. At the time the Comp Plan was put together, EVSC operated 20 elementary, 10 middle, 5 high and 4 alternative schools. Additionally, at the time, the Catholic Diocese of Evansville operated 12 elementary and 2 secondary schools within the county while 2 charter schools were sponsored by the EVSC School Board.

And, for a community our size, it's outstanding to have 3 crown jewels of higher education; the University of Southern Indiana, the University of Evansville and Ivy Tech State College. For the fall semester of 2009, USI's enrollment was well over 10,000 with students from 91 of the 92 Indiana counties, from 41 other states and 63 other counties. USI confers both Bachelors and Master degrees in many different disciplines. University of Evansville has been around since 1854 and currently enrolls slightly more than 2,700 students from 40 states and 50 countries. U of E offers more than 80 areas of study. Ivy Tech State College has 23 campuses around the state and offers classes in 75 different communities performing as a community college. The local Ivy Tech campus located on North First Avenue has current enrollment of over 5,700 students. Additionally, educational opportunities are offered by many local business and trade schools. This vast array of quality educational opportunities helps to serve the community welfare, support good economic development and help to support the goals of the Comprehensive Plan. Just as important, with all of the different geographical areas represented including many different countries, it is incumbent for the Evansville/Vanderburgh County area to make good impressions on those students coming into our region as well as those from this area to assure success for the region. It makes us visible throughout the world.

Along with our great educational opportunities, we also have a rich cultural environment much of which falls under the Arts Council of Southwestern Indiana. The Arts Council serves as an umbrella for more than 50 cultural organizations including theater, dance and music. With such a long list of involvement, I'll not try to list them for fear of missing some but suffice it to say, the Arts Council is a major contributor to our cultural environment. So too are our museums. The Evansville Museum of Arts and Science was founded in 1906. The museum has an extensive collection of art, history, anthropology and science and also houses the Koch Planetarium. The Reitz Home Museum, Angel Mounds, Audubon State Park and Historic New Harmony all add to the areas cultural environment.

Likewise the Evansville-Vanderburgh County Public Library System formed in 1911 with 8 locations contributes greatly to the cultural environment of the area. From its' web site, in 2006 it had a collection of 948,000 items with an additional nearly 6,000 titles in their electronics collection. Over half of Vanderburgh County residents have library cards and in 2006 they had nearly 1.7 million visits.

Certainly, we can't ignore Willard Library opened in 1885 and is the oldest public library building in Indiana. Their major resources include the Thrall Art Book Collection, local government archives, much regional history and a strong emphasis on genealogy. And, they have the Grey Lady Ghost since at least the late 1930's.

Why is all this important to the Comprehensive Plan? Goals of the Comp Plan want to foster an educational system that provides all citizens opportunities for quality, life-long learning as a means of preparing to build a marketable workforce with adaptable skills and foster a healthy environment in which the cultural arts are supported by the community and enhance the quality of life. This is all part of serving and growing a great community.

## **Testing for Census Workers**

The U.S. Census has begun a targeted effort in Southern Indiana to recruit workers to take the census next spring. Census takers (also known as enumerators) are hired to make sure our Southern Indiana cities, towns and counties are represented as accurately as possible. Their primary responsibility is to collect census information from residents that have not sent back their 2010 census form. They also explain the purpose of the census and record their responses.

Census takers will be placed in their own communities. These temporary jobs have flexible schedules and will not exceed 40 hours per week. Census takers will be paid for training and reimbursed for work-related travel.

Testing to become a census taker is in progress now. To apply, call **1-866-861-2010** to find out where and when the census test can be taken. For more information, including a practice test, go to the jobs@census link at www.census.gov.

All census takers must pass a security background check. To qualify for a job with the census, applicants must:

- Be a U.S. Citizen
- Be at least 18 years old
- Have a valid Social Security Number
- Have a valid Driver's License

Bring 2 forms of approved ID to testing site.

# Did U.N.O.E.?

### PUPPY SELECTION by Marlin Beck

#### Question: Where do I start?

**Answer:** Call your local veterinarian ask if they can recommend a good local shelter. Vets will be a good resource in your community for a referral, since they will most probably know what diseases may be prevalent in your area that you should watch out for, as well as which shelters have adopted out the least (and most) aggressive dogs.

#### Question: Where does your puppy start?

Answer: Depends on its destination. My policy is --"Kitchen-to-Kitchen." If your puppy will live life in your house--it needs to be raised inside a breeder's house.

#### Question: What's the big deal about puppies remaining with litter-mates through 8 weeks?

**Answer:** "ABI." "Acquired Bite Inhibition" is without a doubt the most important thing to teach a dog to save his life and your family's safety. A dog with good bite inhibition is no threat to you, children or the community. A dog with poor bite inhibition is a threat to you, children and community. ABI is taught by litter-mates especially during weeks 3 through 7 in the litter. Do not remove from litter prior to 8 weeks.

#### Question: What two things do you not take with you on the first visit to a shelter, breeder, or rescue group?

**Answer:** Your check book and your children. This must be an intelligent not an emotional decision. If you don't have the means to purchase (your check book)---you cannot. If children are absent--so is their influence. You are making a decision that will impact your lifestyle and family for 12-15 years or longer. Take your time.

**Question:** What are the two most important things I can do upon bringing a puppy home to assure success and family sanity? Answer: Socialize and provide for his "Behavioral Needs." The four weeks following your acquisition at 8 weeks of age will impact and form the adult individual more than anything else you may do during your animal's life. This is the "Socialization Period." This socialization window closes at about 12 Weeks of age. Expose your new member to as many non-traumatic experiences that he will have as an adult. Establish house rules for puppy and DO NOT ISOLATE.
