From the President

THE FUN IN STARTING AND RE-STARTING A NEIGHBORHOOD ASSOCIATION

Recently, I had the honor of visiting with a very sharp and trim gentleman, Mr Edward Rhoades, who will be 91 years young on August 8, 2013.He and his daughter Becky Swinehart live in the Rosedale-Garvinwood Neighborhood, north of the Lloyd Expressway.

In 1975, when the Lloyd Expressway was being designed, some of the business owners, along Division St. were trying to relocate their businesses in the Garvinwood neighborhood. Things were in flux for the neighbors, and they gathered in the Rhoades side yard to discuss their options. Many of these homeowners had lived in this neighborhood for a life time and had raised families. They did not want their homes destroyed.

About 50 neighbors attended a City Council Meeting, and told the council of their concerns. Council Chambers were filled. After questions and concerns were presented, the council voted in favor of the neighbors saving their homes.

Several years later, an X-Rated threatre opened in the area, and the patrons were parking on the dark streets in the neighborhoods. Small demur Louise Rhoades did not like their driveways being blocked and people sitting in their cars after the movies were over. So she and Ed gathered the neighbors again and with the help of a mimograph machine and paper purchased from the local Good Will, they passed flyers out in the neighborhood.

So again the, Rhoades and the neighbors went to City Council to ask for street lights. Louise and Ed, and the others left the meeting, knowing that they would soon have street lights in the neighborhood.

In 2013, Ed Rhoades and his daughter, Becky, are restarting the neighborhood association. Issues have arisen, and so they will go to DMD to get the paperwork in order and gather the neighbors of Garvinwood and Rosedale into forming a neighborhood association. Garvinwood Church has offered to let them use the church for the meetings.

The Rhoades know that gathering neighbors into a neighborhood association is a good way to get action for their concerns.

Last year's legislature asked us to prepare a recommendation as to what the law(s) should be concerning the requirements for non-profit entities to have a certified food handler on staff/present during events. In order to gain insight from the public, affected organizations, and local officials alike, we have published an online survey. EPD: Summer Weather and your Pet

Never leave your pets in a parked car

Not even with the car running and air conditioner on. On a warm day, temperatures inside a vehicle can rise rapidly to dangerous levels. On an 85-degree day, for example, the temperature inside a car with the windows opened slightly can reach 102 degrees within 10 minutes. After 30 minutes, the temperature will reach 120 degrees. Your pet may suffer irreversible organ damage or die. If you do happen to see a pet in a car alone during the hot summer months, alert the management of the store where the car is parked. If the owner does not return promptly, call local animal control or the police department immediately.



Watch the humidity

"It's important to remember that it's not just the ambient temperature but also the humidity that can affect your pet," says Dr. Barry Kellogg, VMD, of the <u>Humane Society Veterinary Medical Association</u>. "Animals pant to evaporate moisture from their lungs, which takes heat away from their body. If the humidity is too high, they are unable to cool themselves, and their temperature will skyrocket to dangerous levels—very quickly." Taking a dog's temperature will quickly tell you if there is a serious problem. Dogs' temperatures should not be allowed to get over 104 degrees.

Limit exercise on hot days

Take care when exercising your pet. Adjust intensity and duration of exercise in accordance with the temperature. On very hot days, limit exercise to early morning or evening hours, and be especially careful with pets with white-colored ears, who are more susceptible to skin cancer, and short-nosed pets, who typically have difficulty breathing. Asphalt gets very hot and can burn your pet's paws, so walk your dog on the grass if possible.

Don't rely on a fan

Pets respond differently to heat than humans do. (Dogs, for instance, sweat primarily through their feet.) And fans don't cool off pets as effectively as they do people.

Provide ample shade and water

Any time your pet is outside, make sure he or she has protection from heat and sun and plenty of fresh, cold water. In heat waves, add ice to water when possible. Tree shade and tarps are ideal because they don't obstruct air flow. A doghouse does not provide relief from heat—in fact, it makes it worse.

If your pet is exposed to high temperatures:

Be alert for signs of heat stress-heavy panting, glazed eyes, a rapid pulse, unsteadiness, a staggering gait, vomiting, or a deep red or purple tongue.

If your pet becomes overheated, you must lower her body temperature immediately.

Move your pet into the shade and apply cool (not cold) water all over her body to gradually lower her temperature.

Apply ice packs or cool towels to your pet's head, neck, and chest only.

Let your pet drink small amounts of cool water or lick ice cubes.

Finally, take your pet directly to a veterinarian-it could save her life.


August 6th – National Night Out. Wesselman's Park will be closed to vehicle traffic.

Wesselman Nature Society Certified Backyard Wildlife Habitat Seminar

The seminar is divided into four presentations--

<u>Food For Wildlife</u>, presented by Kate Lynch, Master Gardener/IN Master Naturlist, provides info on what native plant species to use, how to attract birds, butterflies, and beneficial insects to your habitat

<u>Water Is Life</u>, presented by Dennis Pepper, IN Master Naturalist, will teach how wildlife needs water for drinking, bathing, reproduction, and for a safe haven. He will also show many man-made water features you can add to your yard.

Shelter/Places to Raise Young, presented by Kathy Eicher, IN Master Naturalist, will highlight the importance of natural and man-made shelters and safe havens for wildlife. This includes using a diverse selection of native trees and plants, and which shelters are preferred by different animal species.

<u>Sustainable Wildlife Habitat</u>, presented by Deron and Pam Drach, IN Master Naturalists, show through their own experience how to turn an unproductive grass lawn into a wildlife-friendly

BE ALERT TO SCAMS!

Several scams going around the Evansville area:

COMPUTER SCAM BY PHONE:

This happened to our own President-Elect Carolyn Stagg. "I received a phone call the other morning (a male foreign accent): Hi, I am with Microsoft Technology Group. We need you to turn on your Microsoft computer....you do have a Microsoft computer don't you?.. We need you to turn it on and let us take control of it to rid you of the virus and correct other problems you are having.

I told him I was just leaving for work and didn't have the time. But I took my laptop back to my computer man (I had just taken it in to have checked out) and the computer man told me he has had 5 calls already that day on the same thing. He said Microsoft does not take the time to call people to tell them any

thing. You call them for problems. So...don't let anyone take control of your computer over the phone.

HOME SECURITY SCAM: (from the EPD)

Some of our local residents have received calls from a person claiming to be selling home security systems. The person tells the potential customers that the Evansville Police Department will give the person free security signs if the person purchases a security system from them. We don't have the name of the security company, but the person calls from an out of state area code. We want to let the citizens know that we do not endorse any specific security company or provide signs for any company or individual. We cannot validate that this is a legitimate company and they are definitely giving false information about our endorsement.
