GET <u>2000 FREE COPIES</u> TO HELP SPREAD THE WORD IN YOUR NEIGHBORHOOD



A newsletter, flyer or postcard can go a long way in getting the word out about current events to your neighborhood or even the community of Evansville. The UNOE Board recognizes this importance and has voted again in 2017 to give all neighborhood associations <u>2000 free printed copies.</u>


One copy equals one side of an 8 $\frac{1}{2}$ x 11 sheet of paper which costs 5 cents to print if being paid for. If both sides are printed on, it will cost a total of 10 cents. An 11 x 17 sheet of paper consists of four (4) 8 $\frac{1}{2}$ x 11 sides (20 cents). Four (4) postcards can be printed on one piece of cardstock. Front and back of one sheet costs 10 cents or 2 $\frac{1}{2}$ cents for each postcard for printing. A minimum of 200 pieces of mail is needed to use bulk mail postage rate.

New bulk mail rates became effective January 26th, 2017. The bulk mail rate went from .131 to .133 per piece for mail in the zip code areas starting with 477, 476, and 424. In all other "out of area" zip codes, the rate went from .191 to .184 per piece.

All neighborhoods associations are responsible for paying postage. Contact the UNOE office for details.

A bulk mailing can be as small as a post card, and as large as a 12 page newsletter. A single sheet needs to be trifolded with 2 mailing seals. Two pages or booklet are half-folded or quarter-folded with 2 mailing seals.

GET YOUR 2016 TAXES PREPARED FREE

The Volunteer Income Tax Assistance Program of the IRS offers free tax return preparation for individuals with low to moderate income. You may qualify if:

You have taxable income of up to \$60,000 with dependents

Appointments are available at the Legal Aid Society on Monday afternoons from 1:00 p.m. to 3:30 p.m. – January 30, 2017 through April 17, 2017. Appointments are made on a first-come, first-serve basis. Call 435-5173 before 11:30 a.m. to make an appointment for the IRS VITA SITE at the Legal Aid Society in Room 105 of the Civic Center Complex.

PLEASE ARRIVE 15 MINUTES BEFORE YOUR APPOINTMENT and bring the following with you to your appointment:

- Driver's License or Picture Identification Card
- Social Security Card for *each* adult and child
- All Wage and Earnings Statements (W-2s, 1099, etc.)
- List of Itemized Expenses for Self-Employed Individuals
- Social Security Benefit Statements
- Unemployment Statements
- All Health Insurance Information for all family members
- All Interest and/or Dividend Statements
- Last Year's State and Federal Tax Returns
- Proof of Real Estate Taxes Paid
- Landlord's Name & Address and the Total Amount Rent Paid
- Child Care Provider's Name/Address/SSN/TIN# & Total Amount Paid
- Proof of Educational Expenses, including student loan information

SUBJECT: Adverse weather policy

This is a reminder of the policy that is in effect in the advent of adverse weather conditions.

It is the recommendation for the safety and wellbeing for those involved to cancel any and all meetings and minor events that involve the EPD/CPO unit. This policy is in place to help assist those involved to help determine if a meeting or event will be held. While we will attempt to make notifications when possible there may be times when these notifications may be missed. Below are some guidelines to follow if you ever question if a meeting will still take place.

- When local news outlets or National Weather Center issue a weather advisory, a storm watch, storm warning, or other natural disaster that covers the time period of the meeting then that meeting will be cancelled.
- If the EVSC or participating school systems close, then the meeting at those locations will also be cancelled. This may be harder to determine since individual schools may close. If in doubt contact the EVSC or school in question. If EVSC closes because of inclement weather, then meetings should be cancelled also.
- Anytime the City of Evansville announces that the city is closed for whatever reason then all meetings will be cancelled.

This policy is to help insure the elderly, physically challenged, and anyone who walks to meetings stay safe and is not endangered. It is our goal first and foremost to keep people safe and sound. If the organization determines they still want to hold a meeting, that is their decision to do so, but they do so against the advice of the EPD and will do so knowing an officer will NOT attend the meeting.

There is something about the winter months and curling up with a good book by the fireplace. But did you know that heating equipment is one of the leading causes of home fire deaths? With a few simple safety tips and precautions you can prevent most heating fires from happening.

BE WARM AND SAFE THIS WINTER!

- » Keep anything that can burn at least three-feet away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- Have a three-foot "kid-free zone" around open fires and space heaters.
- Never use your oven to heat your home.
- Have a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to the local codes and manufacturer's instructions.

- M Always use the right kind of fuel, specified by the manufacturer, for fuel burning space heaters.
- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.
- III) Test smoke alarms at least once a month.

Heating Equipment Smarts

Install wood burning stoves following manufacturer's instructions or have a professional do the installation. All fuel-burning equipment should be vented to the outside to avoid carbon monoxide (OO) poisoning.

Install and maintain CO alarms to avoid the risk of CO poisoning. If you smell gas in your gas heater, do do not light the appliance. Leave the home immediately and call your local fire department or gas company
